## About the 'Institute'

The provision of animal management services within the community is a significant Local Government task in Australia. Council officers engaged in animal management, work to maximize their community's health, safety and amenity by minimising the negative social, environmental and financial impacts of inappropriately managed animals.

Animal Management is a discipline that endeavours to engage (in a balanced way) the full spectrum of influences that have an effect on and are affected by animal regulatory services. Important among these disciplines are:-

- Human health and welfare;
- Human social science;
- Animal care and welfare;
- Animal behavioural sciences.
- Processes of governance

The Australian Institute of Animal Management Inc (AIAM) is a 'not for profit' incorporated Association. All of the Institute's office bearers and committee members are expected to contribute their service in a voluntary capacity and are obliged to make their own arrangements to attend meetings and functions.

Application for general membership of the Institute is available to all people engaged in the animal management service industry. It is intended that committee members be drawn from all States and Territories in a balanced and representative way. Elections for committee membership will be held each year at the Institute's AGM and arranged usually to coincide with the Institute's annual conference.

**The vision of AIAM** is to assist the development of an environment for best practice in animal management service delivery. In summary, to promote:

- Community health, safety and amenity;
- Animal care and well-being; and
- The benefits of good social and environmental outcomes.

The Institute aims to deliver solutions for people employed in animal management at Federal, State and Local levels of Government.

The following objectives are in effect a summary of Institute member benefits:

- 1 Convening an annual national animal management conference;
- 2 Compiling a body of readily accessible quality literature on this subject;
- 3 Promoting training, career paths and qualification for Animal Management Officers within an accredited national competency framework;
- 4 Maintaining a website that reflects the Institute's activities;
- 5 Producing a quarterly publication to keep in touch with members and others;
- 6 Encouraging best practice in animal management through the sharing of progressive and innovative ideas;
- 7 Recognising excellence in animal management service;
- 8 Fostering a collaborative approach to animal management legislation and policy across Australia; and
- 9 Provide consultancy services on animal management.

## Membership

As mentioned in the previous column, anyone involved in Animal Management service delivery may apply for membership of AIAM inc. This includes for example: AMOs, EHOs, Councillors, Pound Operators, Regulatory Service Officers and so on.

Joining fee (one-off)	= \$20
Annual membership	= \$30
Corporate membership	= \$500

As AIAM inc operates under the threshold of GST, no GST is applicable on membership payments. NOTE: All applications for membership are subject to acceptance by the Executive Committee.

Corporate membership of \$500 allows for five (5) members from the organisation to receive the benefits as allowed for single membership EXCEPT that only one vote is permitted for each Corporate membership. The full names of the five members included in a Corporate membership should be provided to the AIAM Secretariat on registration.
